Note to: STUDENTS & PARENTS
SUPERVISION WAIVER FORMS

NOTE: Supervision waiver form must be filled out each school year with your child (ren) campus.

- PK & K – **MUST ALWAYS** have adult supervision
(If it is a neighbor, Aunt, Uncle, etc....fill form out too)
 - **Parents/Adult need to be within 10 ft of the bus door** when retrieving the students
(NOT in their cars, back in the house doorway, etc)

- 1st & 2nd Graders – must have adult supervision unless parent(s) has signed the supervision waiver form
 - **Parents/Adult need to be within 10 ft of the bus door** when retrieving the students
(NOT in their cars, back in the house doorway, etc)

- 3rd Graders and up – can be released with no supervision
